- collection agencies and credit insurance companies
- business bureaus
- forfeiting companies
- advisors, service companies, certification and auditing companies
- professionals and advisors, bound by professional codes confidentiality, appointed to participate in ordinary management and conflict resolution of the relations stated above.
- companies that operate in the transportation sector
- companies and/or entities directly or indirectly controlled by or related to the undersigned party and belong to the undersigned party's company group,

The personal data will be used for the duration of the contractual relationship, the subsequent execution of applicable laws and commercial purposes.

**Relating to such personal data, your company can exercise the rights provided for by Article 7 of Legislative Decree 196/2003. A copy of the said Article 7 is attached to this letter.**

#### **Article 7 of Legislative Decree 196/2003**

##### **(Rights of the interested party)**

1. The interested party is entitled to obtain the confirmation of the existence or non-existence of the personal information that regards said party, even if it still hasn't been recorded, and its communication in intelligible form.
2. The interested party is entitled to be informed of:
  - a) the source of the personal data;
  - b) purposes and means of usage;
  - c) the means applied in the event of usage carried out with the aid of electronic instruments;
  - d) personal data of the owner, responsible parties, and designated representative pursuant to Article 5, Section 2;
  - e) subjects or categories of subjects to whom/which the personal data may be communicated or may come to the attention of because said subject has been designated representative within the state, or said subject has been designated responsibilities or assignments
3. The interested party is entitled to obtain:
  - a) updates, adjustments and supplements to the data when they are of interest to said party;
  - b) deletions, redaction, or freezing of personal data used which are in violation of the law, including those which are not necessary to save with respect to the purposes for which the personal data have been collected and subsequently used;
  - c) certification that the transactions pursuant to letters a) and b) as well as transactions relating to such provisions have been brought to the attention of interested parties, whose personal data carried have been communicated or circulated, except in the event that such fulfillment may prove to be impossible or may involve a means of execution that proves to be disproportionate to the right of safekeeping.
- 4) The interested party has the right to oppose completely or partially:
  - a) the usage of interested party's personal data for legitimate reasons, even if such data pertains to the purpose of collecting such data;
  - b) the usage of interested party's personal data for purposes of sending publicity material, or engaging in direct sales, performing market research or business communication.
